Dear Friends, Families, Residents and Caregivers,

We are making a consolidated effort to defeat COVID-19 through vaccinations of our staff and residents.

The vaccine is a measure of hope in stopping the pandemic and protecting our residents and their families as well as our staff and their families. With the positive of a resident, we reimplemented the yellow zone on Neighbor Way and the red zone on Nostalgia Way.

We are participating with the Vaccine Partnership Program. Our pharmacy partner is providing onsite vaccination clinics for our staff and residents. The vaccine includes a series of two injections, scheduled 21 to 28 days apart. The next CVS Vaccination Clinic Schedule is January 25 and February 15.

This week, Johnson and Johnson's COVID-19 vaccine was marketed as promising. It is a single injection and delivers spike proteins through a disabled common cold virus that cannot infect the recipient. It is hoped to be available in early summer.

Even with the hope of an effective vaccine in the coming year, we encourage all to maintain physical distancing, use caution when attending gatherings, wear a mask and practice hand hygiene.

In keeping up with COVID-19 challenges, we have enacted the most recent Centers for Medicare & Medicaid Services (CMS) guidelines regarding visitation. These guidelines are based on county positivity rates. We continue to watch our county positivity rates very closely in the hopes that we can invite you back into the facility to visit your loved one.

We remain focused on principles of cleanliness set forth by policies and procedures from the Centers for Disease Control (CDC), Department of Health (DOH), and RCAT (Regional Congregate Care Assistance Team), which was formerly known as Regional Response Health Collaboration Program (RRHCP). Total cases in Indiana County is 4,116 with 136 deaths.

22	COVID-19 DEATHS: Residents with suspected or laboratory positive COVID-19 who died in the facility or another location.
